

Borrowing money

May result in risk of financial failure

Attempting to accelerate customer collections

Delaying payments

Writing checks against future receipts not yet deposited

Slowing expansion plans

Establishing bank overdraft protection or a line of credit

Issuing additional capital stock

Planning full utilization of cash flows, with no reserves
